
Procedural Order Re: Record Requests

On July 20, 2023, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) filed a compliance tariff in conformance with Order No. 26,854. On August 18, 2023, the tariff administrator issued a letter of provisional non-compliance with respect to this tariff filing because the Commission could not confirm the Energy Service rates for Rate Class D-11 and Rate EV based on the information Liberty provided. Specifically, the letter noted that the Energy Service rates for these rate classes did not match the illustrative tariff pages that Liberty filed on June 27, 2023, and that Liberty did not provide an explanation as to why the rates in the compliance tariff differed from those in the illustrative tariff. The Commission now directs Liberty to provide an explanation as to how it determined the Energy Service rates for Rate Class D-11 and Rate EV in the compliance tariff by August 28, 2023 so that the Commission can review and confirm compliance with Order No. 26,854.


