**Procedural Order Re: Request to Reschedule March 13, 2024 Hearing**

The Commission scheduled a hearing in the above-captioned matter on March 13, 2024 in a supplemental order of notice issued on February 8, 2024. On February 8, 2024, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) filed a request to reschedule this hearing to March 18, 2024 or a date thereafter, stating that Liberty's counsel had previously planned to be away during the week of March 11, 2024. Liberty noted that neither the New Hampshire Department of Energy nor the Office of the Consumer Advocate objected to its request.

Liberty's request to reschedule the March 13 hearing is GRANTED. This hearing is rescheduled to March 20, 2024, starting at 9:00 a.m. The hearing shall be conducted in person, in accordance with the previously issued hearing guidelines.
