On July 12, 2023, the Commission issued a procedural order requesting the Department of Energy (DOE) file a status update regarding the DOE investigation of the complaint in the above-captioned matter.

The DOE is still conducting its investigation of the complaint pursuant to RSA 365:1-4. The DOE has requested information from Unitil Energy Systems, Inc. (Unitil), and is expecting a response on or before July 20, 2023.
