Dear Chairman Goldner:

On October 13, 2022, Public Service Company of New Hampshire d/b/a Eversource Energy (“Eversource”) submitted a compliance filing in Docket No. DE 21-078, as directed in the Commission’s Order No. 26,690 (September 28, 2022), that contained the following original tariff pages for Primary General Delivery Service Rate EV-2:

Original Page 65-G
Effective: December 15, 2022

The Commission’s Tariff Administrator issued a letter on November 9, 2022 confirming that the tariff page submission complied with the Puc 1603 filing requirements.

The tariff pages submitted in Docket No. 21-078 inadvertently failed to include a reference to the applicable Regulatory Reconciliation Adjustment charge in the amount of 0.084¢ per kWh, thereby incorrectly omitting that charge from the tariff provisions for Primary General Delivery Service Rate EV-2. The same tariff page also includes a reference to the System Benefits Charge that Eversource proposes to delete because the System Benefits Charge is uniformly applied to all rate schedules and is already included in the Terms and Conditions Section of the tariff on page 22.

Eversource seeks to make these corrections by filing the enclosed revised tariff page 65-F for Rate EV-2, in both clean and annotated versions, that now includes the Regulatory Reconciliation Adjustment charge in the amount of 0.084¢ per kWh and deletes the System Benefits Charge reference. Eversource requests that the Commission accept and approve the revised page 65-F at the earliest possible time, in order to include all appropriate charges applicable to the Primary General Delivery Service Rate EV-2 customer rate class.
