AFFIDAVIT

John Moore, being duly sworn, deposes and states that:

- 1. I am over the age of eighteen and understand the obligation of making a statement under oath.
- 2. I am Senior Manager, Accessibility for T-Mobile USA, Inc. ("T-Mobile"), the petitioner in the above-captioned docket, which involves T-Mobile's request to discontinue its Captioned Telephone Service ("CapTel") service in New Hampshire beginning October 1, 2023.
- 3. On August 31, 2023, the New Hampshire Public Utilities Commission ("Commission") issued Order No. 26,880, Order *Nisi* Approving Petition to Terminate (the "Order").
- 4. In the Order, the Commission directed T-Mobile to: "inform each of its eleven effected analog Captioned Telephone Service customers of this order through written notice, such notice to be made no later than September 5, 2023, and to be documented by affidavit filed with the Commission on or before September 11, 2023."
- I certify that as of September 1, 2023, all CapTel users, upon making or receiving a CapTel call within New Hampshire, will receive the following written message: New Hampshire CapTel service will end after September 30, 2023. NH residents discuss your options by calling 888-269-7477 or press blue button for care support.¹
- 6. Upon calling the displayed number or pressing the blue button, the user will be connected to CapTel customer service representatives. The user will be informed of the service discontinuation and provided options for continuing services, such as upgrading to an Internet CapTel phone at no charge, or provided a way to contact the New Hampshire Telecommunications Equipment Assistance Program (NH-TEAP), the authorized state telephone equipment distribution program, for additional support. NH-TEAP is a local organization that specializes in support for New Hampshire residents with disabilities and would be able to provide information and training on continuing communication services. For example, they would be able to

teach the user how to use their CapTel phone in Voice Carry Over (VCO) mode, which is a mandatory form of relay services. They will also be able to help the user learn about internet or mobile application options that will be available after CapTel service ends.

- 7. T-Mobile is bound by relay service regulations and does not distribute CapTel equipment. For this reason, T-Mobile does not have contact information for CapTel users in New Hampshire. To further ensure that all New Hampshire CapTel users are notified of the service discontinuation, T-Mobile is coordinating with NH-TEAP to notify active CapTel users via mail. By coordinating with the New Hampshire telephone EDP and CapTel, NH-TEAP will mail notices to active users as soon as possible.
