
Public Service Company of New Hampshire d/b/a Eversource Energy, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty, Unitil Energy Systems, Inc., the New Hampshire Department of Energy, Conservation Law Foundation, the Office of the Consumer Advocate, and the Community Power Coalition of New Hampshire have conferred and agreed upon the proposed procedural schedule—there were no objections to this proposal, but there was no response from Colonial Power Group. Please note that the parties, after considerable discussion at the technical session following the prehearing conference, decided that legal briefs are at a minimum premature at this time, and perhaps unnecessary for this docket. Further the parties agreed that any extended version of comments made at the prehearing conference, which were nonbinding preliminary statements, may be provided as part of testimony that will be filed by parties on December 20. At this time the above-named parties propose the following:

September 15, 2023	Deadline for Round 1 DRs
September 29, 2023	Deadline for Responses to Round 1 DRs
October 10, 2023	Technical Session/Settlement Conference: 9 a.m. – 12 p.m.
October 24, 2023	Round 2 Data Requests Deadline or Possible Settlement filing with PUC to determine an early Settlement Hearing date
November 7, 2023	Round 2 Data Request Responses
December 20, 2023	Testimony – all parties
January 9, 2024	Tech Session/ Settlement Conference
January 16, 2024	Tech Session/Settlement Conference
February 2, 2024	Technical Session data request responses
February 8, 2024	Deadline to File Settlement
February 22, 2024	Hearing

The above-named parties also agreed that the New Hampshire EDI working group should be reconstituted and reconvened to consider NH EDI standards and how they might facilitate sharing of customer net metering data as well as other EDI matters and potential changes. The parties suggest that all parties to this docket would be participants in the Working Group, as well as inviting all third party energy suppliers serving customers in NH and all EDI vendors, as any changes to EDI would directly affect them. The above-named parties respectfully request that the Commission authorize the convening of the EDI Working Group when it approves the procedural schedule in a prehearing order.
