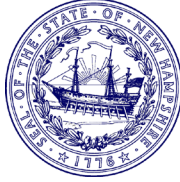

Dear Chairman Goldner:

On August 14, 2023, the New Hampshire Public Utilities Commission (PUC) approved the procedural schedule (Schedule) filed in this matter by the New Hampshire Department of Energy (DOE or Department). The Department is filing this letter to inform the PUC of a slight modification to the Schedule. DOE is proposing these changes because it needs additional time to prepare for the technical session in this docket. Unitil Energy System, Inc. (Unitil or UES) agrees with these proposed changes. The two changes to the Schedule are shown below highlighted; they do not impact the hearing date or deadline for DOE's recommendation to the PUC.
