
Chairman Goldner:

On August 23, 2023, the New Hampshire Public Utilities Commission issued a Commencement Of Adjudicative Proceeding And Notice Of Hearing in Docket No. DE 22-070. In part that Notice required that “Eversource shall notify all entities and individuals desiring to be heard at this hearing by publishing a copy of this order of notice on its website no later than two business days after the date of issue, such publication to be documented by affidavit filed with the Commission on or before September 5, 2023.” Notice at 5. Two business days would have been by the end of the day on Friday August 25.

Due to staff vacations, Public Service Company of New Hampshire d/b/a Eversource Energy didn’t publish the notice on the Eversource website until today on August 28, 2023. An affidavit and screenshot of the publication are attached to this filing to attest to the fact that the notice was published on August 28. The Company apologizes for the delay, but since the publication was only delayed by one business day, there are still eight days until hearing, and the notice was also posted on the Commission’s website, the Company believes that adequate notice has been provided and no party or member of the public will be unduly prejudiced by the one business-day delay of publication on the Eversource website.
