### Re: DE 23-073, Low Income Electric Assistance Program Amended EAP Administrative Budget

Dear Chairman Goldner,

On August 9, 2023, the Public Utilities Commission ("Commission") issued Order No. 26,870 (the "Order"), approving certain recommended modifications to the Electric Assistance Program ("EAP"). One of the recommendations was to re-allocate benefits among the benefit tiers. (See Order at 3). To implement this recommendation the Commission in the Order "approve[s] and order[s] this reallocation for integration by the Utilities, the CAAs, and the DOE as of the beginning of the upcoming program year as of October 1, 2023, and direct[s] the Utilities and CAAs to make any changes necessary for the integration of the new discount structure into their annual budget petitions filed in Docket No. 23-073 forthwith." Pursuant to that directive, Unitil Energy Systems, Inc. hereby submits the attached revised EAP budget to this docket for review and approval by the Commission.
