In accordance with Puc 2204.01 Submission of Electric Aggregation Plans to the Commission for Review and Approval, the Town of Stratham is notifying the NH PUC, the NH DOE, the Office of the Consumer Advocate and the Utility (Unitil) that its Community Power Electric Aggregation Plan was approved by the Voters present at a Special Town Meeting held on October 26, 2023. The Plan is now fully approved and was adopted by the Energy Aggregation Committee on July 11, 2023, approved by the Select Board on July 31, 2023, the NH PUC on September 30, 2023 and the Voters at a Special Town Meeting on October 26, 2023. The final approved Plan is attached to this email.


