Dear Chairman Goldner:

At a February 1, 2024, hearing in the above-captioned docket, the Commission scheduled a continued hearing for March 27, 2024, at 9:00 a.m.<sup>1</sup> The Department of Energy ("Department") filed a letter with the Commission on February 29, 2024, requesting clarification of the tariff suspension date in this matter. The Commission issued a procedural order on February 29, 2024, suspending the proposed tariff until May 29, 2024, pending investigation and further order of the Commission. In its February 29, 2024, procedural order, the Commission noted that it, "expects to issue a further procedural order in this proceeding in late April to accommodate further analysis and hearing(s) regarding this matter." The Department therefore requests clarification of whether the March 27, 2024, hearing will take place as scheduled, or whether that hearing has been cancelled.
