## Re: DG 23-084; Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Keene Division Winter 2023-2024 Cost of Gas Filing

Dear Chairman Goldner:

The Commission issued Order No. 26,900 (Oct. 31, 2023) (the "Order) approving the cost of gas rates for the Company's Keene Division. On behalf of Liberty Utilities (EnergyNorth Natural Gas) Corp., I write to inform the Commission (1) that the Order contains a clerical error in approving one of the rate components, and (2) that the Company intends to bill the correct rate.

The Company's filing proposed the following rates:

Exhibits 1 and 2, at Bates 020. Note the proposed Fixed Price Option (FPO) Gas Assistance Program (GAP) rate of \$0.7814.

The ordering clause on page 6 of the Order contains the following table with the approved rates that the Company is to bill its customers:

C&I - LLF (High winter use)	\$1.4007	\$1.7509

C&I FPO	\$1.4207	

Note the incorrect FPO GAP rate of \$0.7904.

Since there was no discussion in the Order or at hearing indicating the Commission intended to approve an FPO GAP rate other than as proposed in the Company's filing, the Company assumes that the Order's incorrect FPO GAP rate is the result of a clerical error.

Therefore, the Company intends to bill the correct FPO GAP rate of \$0.7814.
