Dear Chairm an Goldner:

The Commission just issued a correction to Order No. 26,900 (Oct. 31, 2023) that addressed an error in the FPO GAP rate that Liberty brought to its attention by letter dated October 31, 2023. On behalf of Liberty Utilities (EnergyNorth Natural Gas) Corp., I write to point the Commission to a related error -- and to sincerely apologize for not making this clear in the October 31 letter -- and to again inform the Commission that we will bill the corrected rate.

The Company's filing proposed a GAP rate of \$0.7704 and an FPO GAP rate of \$0.78 14. Order No. 26,900 initially approved a GAP rate of \$0.78 14 and an FPO GAP rate of \$0.7904. The Company's October 31 letter noted that the Commission's FPO GAP rate should have been \$0.78 14 (and not \$0.7904), which the Commission corrected on November 1. The Company's October 31 letter did not point out that a correction of the FPO GAP rate triggered a necessary adjustment to the GAP rate as they would otherwise be the same, \$0.78 14, when, of course, they should differ. The correct (non-FPO) GAP rate is \$0.7704. Below are the relevant schedules from the Company's filing and the original order as contained in the October 31 letter.

The Company intends to bill the corrected GAP rate of \$0.7704.
