Dear Chairman Goldner:

On December 4, 2023, the Commission issued a procedural order directing Pennichuck Water Works, Inc.; Pennichuck East Utility, Inc.; and Pittsfield Aqueduct Company, Inc. to file live Excel workbooks for schedules that originated as Excel documents but were then converted into PDFs. The Commission directed the companies to file the Excel versions as a matter of course. Lastly, the Commission stated that the Excel files should have clear reference and formula links across the associated files.

Please know that on November 21, 2023, when the companies filed the consolidated rate case filing, they provided the Commission's clerk's office with the live Excel workbooks for all of the Puc 1604.06 and Puc 1604.08 schedules as well as for DLW Exh. 1 (which is the workbook that includes calculations of the rate stabilization fund balances). The companies provide these Excel versions for their rate cases as a matter of course. Please see the attached email which lists the attachments and their type. All workbooks have clear references to the formulas and the workbooks related to each individual company are linked.

If for some reason the links between workbooks have become broken, the companies will promptly work with the clerk's office to ensure that the Commission has the electronic versions it needs.
