On November 3, 2023, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a petition for approval of financing, in which it requested the Public Utilities Commission (Commission or PUC) to issue an order *nisi* by February 15, 2024. On November 21, 2023, the Public Utilities Commission issued an order requesting the Department of Energy (Department or DOE) to file a recommendation on Eversource's petition by December 19, 2023. The Department has reviewed the PUC's procedural order and has determined that it needs additional time to review the Petition, conduct discovery, and make its recommendation.
