

1. I represent New Hampshire Electric Cooperative, Inc. ("NHEC") in the above-captioned docket concerning the adjustments to the System Benefits Charge and Local Distribution Adjustment Charge assessed by New Hampshire's Electric and Gas Utilities ("the Joint Utilities") to take effect on January 1, 2024.
