
**Procedural Order Re: Requesting a City of Nashua Representative's Attendance at  
the January 14, 2025 Hearing**

The Commission has reviewed the parties proposed witness panel for the January 14, 2025 hearing. The Commission notes the absence of a representative from the City of Nashua (Nashua or the City) who is qualified to answer any follow up questions the Commission may have concerning section 3.0 of the settlement, entitled Summary of City of Nashua Approvals, from the witness list.

The status of Nashua's approval of the merger agreement is paramount to the Commission's final determination on the settlement agreement and therefore the Commission is requesting that a witness be present from Nashua who could respond to additional questions from the Commission surrounding the City's approval of the proposed merger should they arise during the course of the hearing.

The Commission requests that Nashua identify its witness, and position with the City, no later than 1:00 pm on January 13, 2025 by filing the information with the Commission's Clerk's Office.
