Procedural Order Re: Rescheduling Prehearing Conference

This matter involves consolidation of Pennichuck East Utility, Inc. (PEU) and Pittsfield Aqueduct Company (PAC) with Pennichuck Water Works, Inc (PWW). The parties are scheduled for a pre-hearing conference in this docket on Tuesday, February 6, 2024.

In a separate docket, Docket No. DW 23-088, PEU, PAC and PWW's requested approval of a consolidated rate. In Docket No. DW 23-088 the parties appeared on January 31, 2024 for hearing on the Department of Energy's motion to dismiss the consolidated rate petition. At the conclusion of the January 31, 2024 hearing, the Commission took the matter of dismissal under advisement. The Commission anticipates issuing a decision on the motion in the near future.

In the interest of judicial economy, and fairness to the parties, the Commission CANCELS the February 6, 2024 prehearing conference and reschedules it to Wednesday February 14, 2024 from 9:00 am to 12:00pm.
