On May 3, 2024, the New Hampshire Department of Energy ("DOE" or "the Department") filed a *Motion to Make Northern a Mandatory Party* and *Motion to Make Liberty a Mandatory Party* in this docket. Those motions included DOE's request that the ten-day response period be shortened to a five-day period. See Puc 201.05, 203.07 (e).
