Dear Chairman Goldner:

On April 11, 2024, Liberty filed a proposed procurement timeline stating Liberty would submit its Energy Service Filing to the Commission on **June 21, 2024**. On May 9, 2024, in Docket No. DE 24-061, the Commission issued its *Commencement of Adjudicative Proceeding and Notice of Hearing* stating that the Department of Energy “shall file its petition [sic] regarding Liberty's petition, including the reasons for this position, on or before **June 11, 2024;**” (emphasis added). The Commission scheduled the hearing in DE 24-061 for **June 25, 2024**.

Given the abbreviated timeline between the default service filing and hearing, the Department of Energy submits this letter to respectfully notify the Commission that it intends to provide its position at the June 25 hearing, after it has an opportunity to review Liberty's default service petition and resulting rates.
