
Procedural Order Re: Eversource Request for Extension of Time

On November 26, 2024, counsel for Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a request with the Commission requesting an extension of time to submit responses to the Commission's Record Requests #50 through #52 in this instant proceeding, which were presented to Eversource in a procedural order on November 21, 2024. (Eversource submitted a corrective filing to this motion on November 27, 2024, correcting the numeric references for the Record Requests). Eversource requests until December 11, 2024 to provide its responses, with the original deadline established by the Commission being December 2, 2024. Having reviewed Eversource's request, the Commission hereby EXTENDS the deadline for Eversource's responses to Record Requests #50 through #52 to December 6, 2024. Due to Commission scheduling commitments in December, it is critical for Eversource to provide these responses as expeditiously as possible. Given the short amount of time remaining before this revised December 6 deadline, the Commission also hereby WAIVES New Hampshire Code of Administrative Rules, Puc 203.07(e).
