On May 24, 2024, the Commission issued an order of notice in Docket No. DE 24-077 regarding Unitil Energy Systems, Inc.'s (UES) proposed adjustment to its revenue decoupling adjustment factor (RDAF) for effect on August 1, 2024, which scheduled a hearing on July 30, 2024.
