Good Afternoon Chairman Goldner:

On July 24, 2024, Richard M. Casale, Trustee of the Casale Family 2005 (“the Casale Trust”) pursuant to a Letter of Authorization of Charles M. Mobilia Individually and as President of Lakeview Water Company Inc. petitioned the New Hampshire Public Utilities Commission (“PUC”) to approve its request to permanently discontinue the service of Lakeview Water Company, Inc. In order to avoid the need for the Prehearing Conference currently scheduled for October 10th at 9 a.m., the Casale Trust proposes the following procedural schedule, to which the DOE has agreed.


