**Assented to Motion for Substitution of Petitioner and Permanent Withdrawal**

The original Petitioner, Richard M. Casale, Trustee of the Casale Family 2005 Irrevocable Trust (“the Trust”) hereby requests to Substitute as Petitioner in the above-captioned case Lakeview Water Company, Inc. (“the Company”); and in support of this Motion the Trust states as follows:

1. The Trust initially brought this action with the permission of the Company’s last president and sole shareholder Charles Mobilia.
2. Following the Technical Session conducted in this case on December 5, 2024, it became apparent that the Company may need to take a much more active role in this matter.
3. The Company is now represented by Attorney Marcia Brown, who has appeared in this case for the Company.
4. Accordingly, the Trust respectfully requests that the Company be substituted as the Petitioner in this matter and that the Trust be removed as a party in this case.
5. Similarly, the Trust’s attorney, Christopher L. Boldt of the Law Firm of Donahue, Tucker and Ciandella, PLLC, respectfully requests to withdraw from this case and to be removed from the service list of this case.


6. Attorney Brown has given her assent to this Motion on behalf of the Company.


