**LIBERTY UTILITIES (ENERGYNORTH NATURAL GAS) CORP. d/b/a LIBERTY  
2025-2026 Local Distribution Adjustment Charge**

**Procedural Order Re: Request for Waiver**

On November 20, 2024, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) filed an updated petition to adjust its Local Distribution Adjustment Charge (LDAC) for effect February 1, 2025. In the cover letter attached to the petition, Liberty requested a waiver from both New Hampshire Code of Administrative Rules, Puc 1603.05 and the guidelines approved in Order No. 26,872 (August 14, 2023), which require Liberty to file proposed tariff pages demonstrating any rate impacts whenever it files a petition to adjust its rates. See Puc 201.05 (allowing parties to request waivers from other Commission rules). Specifically, Liberty seeks an exemption from filing Pages 87 and 89, which contain their summary rate schedules, on the grounds that these pages will become outdated due to other rate changes that will take effect before February 1. Liberty notes that other tariff pages in its filing will demonstrate the proposed LDAC charges. No objections to the request were filed. The Commission finds that a waiver is appropriate pursuant to Puc 201.05, and therefore GRANTS Liberty's request.
