Unitil - Petition for Approval of Revenue Decoupling Adjustment Factor and Waiver of Revenue Decoupling Adjustment Cap (DG 24-103)

Gas, Dual Gas & Electric

On September 16, 2024, Northern Utilities, Inc. (Northern) filed a petition for approval of separate Revenue Decoupling Adjustment Factor (RDAF) rates effective from November 1, 2024 to April 30, 2025 and from May 1, 2025 to October 31, 2025. Northern also requested a waiver of the Revenue Decoupling Adjustment Cap (cap) and authorization to collect the proposed RDAF over a 24 month period rather than 12 months. In support of its petition, Northern filed proposed tariff pages and the pre-filed joint testimony of employees S. Elena Demeris and Daniel T. Nawazelski.
