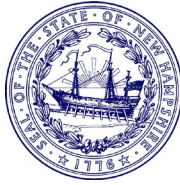

Dear Chairman Goldner:

The New Hampshire Public Utilities Commission (“PUC”) requested that the parties propose a draft schedule to discuss recovery of the Energy Service Rate Reconciliation Adjustment Factor charges initial proposed for recovery in this docket. The parties, Public Service Company of New Hampshire d/b/a Eversource Energy, the Office of the Consumer Advocate, Community Power Coalition of New Hampshire, Colonial Power Group, Inc., NRG Retail Companies’, and the New Hampshire Department of Energy conferred and propose the following schedule.
