**Procedural Order Re: Granting of Colonial Power Group, Inc.
Late-Filed Motion to Intervene**


The Commission issues this ruling in response to the late-filed motion to intervene in this docket, pertaining to the Stranded Cost Recovery Charge (SCRC) proposals made by Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource, or the Company), by Colonial Power Group, Inc. (Colonial).

Colonial filed its motion to intervene on December 31, 2024, four days after the December 27, 2024 deadline for motions to intervene established by the Commission's commencement of adjudicative proceeding and notice of hearing order dated December 12, 2024. Colonial did not address the reasons for its late-filed motion to intervene.

Having received no objections to Colonial's motion to intervene within the 10-day objection period established by N.H. Admin. R., Puc 203.07(e), the Commission GRANTS Colonial's petition for intervention, per RSA 541-A:32, II and N.H. Admin. R., Puc 203.17, as the Commission finds that Colonial's participation is in the interest of justice and may assist in the Commission's determination of the issues noticed in this SCRC proceeding.
