**Petition to Approve Battery Storage Pilot Program**

**Procedural Order Re: January 10, 2023 Hearing**


By procedural order dated September 26, 2022, the Commission scheduled a hearing in the above-captioned matter on January 10, 2023. As one of the Commissioners has been recused in this docket and another Commissioner recently became ill, the Commission has rescheduled this matter to Tuesday, February 7, 2023, starting at 1:30 p.m. Three hours have been allotted for this hearing, which shall be conducted in person, in accordance with the hearing guidelines issued on May 3, 2022.

The Commission renews its request that Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) coordinate with Tesla, Inc. (Tesla) to have a Tesla representative available, either in person or remotely, at the February 7 hearing to respond to any questions that may arise regarding the physical and technological capabilities of Tesla products and software utilized in Liberty's Battery Storage Pilot Program. *See* Procedural Order dated August 22, 2022. In accordance with the Procedural Order dated January 5, 2023, Kevin Joyce from Tesla, Dmitry Balashov from Liberty, and Kajal Gaur from Guidehouse, Inc. will be permitted to participate remotely at the February 7 hearing. The filing of a separate request will be required for any other parties or witnesses wishing to appear remotely.
