Procedural Order Re: Closing Docket

On September 11, 2023, the Commission issued Order No. 26,882, an order *nisi* that approved the parties' settlement agreement resolving the issues raised in Public Service Company of New Hampshire d/b/a Eversource Energy's (Eversource) appeal to the New Hampshire Supreme Court. Order No. 26,882 set a deadline of October 6, 2023 for filing comments and requests for a hearing, but none was filed. It also stated that the order would become effective on October 20, 2023, unless Eversource failed to comply with its publication obligation or the Commission issued a supplemental order before this date, neither of which occurred.

Accordingly, this docket is now closed. The Commission, however, will continue to accept any periodic reports required by approved agreements or orders of the Commission in this docket and post them to the docket.
