
Procedural Order Re: Request to Reschedule Hearing

By procedural order dated February 17, 2023, the Commission scheduled a hearing in the above-captioned matter on April 6, 2023 regarding Hampstead Area Water Company, Inc.'s (HAWC) request for approval of the Step I Adjustment. On February 21, 2023, Intervenor Karen Steele filed a request to reschedule the April 6 hearing. She filed a request on March 2, 2023 for the information contained in her February 21 letter to be treated as confidential.

The New Hampshire Department of Energy notified the Commission on March 2, 2023 that it had no objection to Ms. Steele's request to reschedule. On March 3, 2023, HAWC filed a response stating that it had no objection to a short continuance but, alternatively, it proposed that the hearing go forward on April 6, with Ms. Steele being permitted to participate in the hearing remotely.

As there has been no objection to Ms. Steele's request for confidential treatment and HAWC does not object to a short continuance, the requests for confidential treatment and rescheduling of the April 6 hearing have been GRANTED. Accordingly, the April 6 hearing has been rescheduled to April 12, 2023, starting at 1:30 p.m. Three hours are allotted for this hearing, which shall be conducted in person, in accordance with the hearing guidelines issued on October 18, 2022.
