Petition for Electric Vehicle Make-Ready and Demand Charge Alternative Proposals

Procedural Order Re: Record Requests

The Commission requests that Public Service Company of New Hampshire d/b/a
Eversource Energy (Eversource or the Company) respond to the following record requests,
which were made at the July 14, 2022 hearing, on or before the close of business on
Thursday, July 21, 2022:

Record Request 1

The Company should coordinate with the New Hampshire Department of Environmental Services (NHDES) and provide a copy of the Volkswagen Settlement Request For Proposals (RFP) document(s) for EV-related infrastructure.

Record Request 2

The Company is to provide a detailed cost breakdown for the average site cost of approximately \$410,000 delineated in the Settlement Agreement schedules (Ref. Hearing Exhibit 1, Bates Page 32, Lines 8-9), for both in-front of the meter and behind the meter infrastructure.

Record Request 3

Based on the proposed rate design (A4), the Company is to calculate and provide the dollar amount of the subsidy afforded to EV charging stations by the (A4) rate if the utilization rate would be 5 percent (presuming a 120 kW demand level).

A continuation of the July 14 hearing has been scheduled on <u>Tuesday</u>, <u>August 9</u>, <u>2022</u>, at 9:00 a.m. Three hours have been allotted for this hearing, which shall be conducted in accordance with the hearing guidelines issued on April 18, 2022. A representative of the NHDES is requested to be present at the August 9 hearing.

The August 9 hearing will be conducted using a hybrid format to accommodate the following witnesses, if they will be attending, whose in-person attendance was previously excused due to the significant distance they would have to travel to Concord, New Hampshire: Conservation Law Foundation and Clean Energy New Hampshire's consultant, Christopher Villarreal; the New Hampshire Department of Energy's witness, Sanem Sergici; and ChargePoint, Inc.'s counsel, Nikhil Vijaykar, and witness, Matthew Deal. The following Eversource witnesses will also be permitted to appear remotely at the August 9 hearing: Edward Davis, Kevin Boughan, and Marisa Paruta.
