Procedural Order Re: August 9, 2022 Hearing


During the continued hearing in this matter scheduled on August 9, 2022, the Commission requests that the New Hampshire Department of Environmental Services (NHDES) make Ms. Rebecca Ohler of NHDES available for sworn testimony. The Commission also requests that any individuals who testified during the July 14, 2022 hearing be available to testify at the August 9 hearing, with the exception of the New Hampshire Department of Energy's (DOE) witness, Dr. Sanem Sergici. The DOE notified the Commission on August 3, 2022, that Dr. Sergici will be out of the country on August 9 and stated that questions for Dr. Sergici could be answered either through witness Elizabeth Nixon or a record request.

After the August 9 hearing, the parties shall file written closing statements no later than August 10, 2022.


