# New Hampshire Code of Administrative Rules Chapter 2200 Municipal and County Aggregation Rules

#### Procedural Order Re: Interim Guidance on Compliance with Puc 2203.01(b)

New Hampshire Code of Administrative Rules, Puc 2203.01, effective October 12,

2022, requires that each

...utility shall provide to the commission and the department of energy current contact information that can be posted on the commission and the department of energy's websites as to the mailing or email address to be used for notices from a committee to the utility required under these rules and for requests for information from a committee or CPA to the utility under these rules. That information as submitted by the utility shall be posted on the commission and the department of energy's websites.

Whereas the Commission is making minimal updates to the format of its existing website

pending the launch of a new website that meets the State of New Hampshire's current

information technology standards, a specific webpage for community power aggregation

information is expected to be built in early 2023. Therefore, until a webpage for community

power aggregation information on the Commission website is available, the Commission

construes letters filed in the instant docket containing utility contact information required

by Puc 2203.01(b) to be compliant with the filing and posting requirements of Puc

2203.01(b).
