Procedural Order Re: Motion for Remote Participation


The Commission scheduled an in-person hearing on January 11, 2023 to review Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty's (Liberty) proposal for providing default service to its Large Customer Group for the period of February 1, 2023 through April 30, 2023, which is expected to be filed on this date. See Procedural Order dated January 5, 2023. On January 5, 2023, Liberty filed a request for remote participation by Aaron Doll, a Liberty employee based in Joplin, Missouri, due to travel costs. Liberty did not state whether its motion for remote participation was assented to by the other parties.

Given the limited time remaining before the January 11 hearing, the Commission waives the 10-day objection period under New Hampshire Code of Administrative Rules, Puc 203.07(e). See N.H. Admin. R., Puc 201.05. Consistent with the procedural orders dated November 15, 2022 and December 16, 2022, in which the Commission previously granted Mr. Doll leave to appear remotely, the Commission GRANTS Liberty's motion for remote participation regarding the January 11 hearing. Therefore, a hybrid hearing format will be used for this hearing to accommodate Mr. Doll only. The filing of a separate request will be required for any other parties or witnesses wishing to appear remotely.


