Procedural Order Re: Request for Additional Time

The Procedural Order issued on December 4, 2023 granted the New Hampshire Department of Energy's (DOE) request "to file a supplemental technical statement on or before January 19, 2024." The DOE did not file its supplemental technical statement by this date or request an extension of this deadline. The Commission sua sponte extended the January 19 deadline to February 2, 2024. See Procedural Order dated January 31, 2024 (citing Procedural Order dated December 4, 2023).


On January 31, 2024, the DOE submitted a request for additional time to file its supplemental technical statement, stating that it could not provide a complete analysis by the February 2 deadline. The DOE noted that it intends to file a proposed procedural schedule, which would include a new deadline for the supplemental technical statement, by February 6, 2024. It did not state whether the other parties in this docket assented to its request for relief.

Since the current February 2 deadline expires today, the Commission waives New Hampshire Code of Administrative Rules, Puc 203.07(e). The DOE's request for additional time is GRANTED, so that the DOE shall file a proposed procedural schedule, to include a deadline for its supplemental technical statement, on or before February 15, 2024.


