**Request for Approval of Revenue Decoupling Adjustment**

**Procedural Order Re: Filing Deadlines**

On November 15, 2022, the Commission held a duly noticed hearing in the above-captioned matter relating to Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty's (Liberty) revenue decoupling adjustment for the decoupling year ending June 30, 2022. At the hearing, Liberty, the New Hampshire Department of Energy (DOE), and the Office of the Consumer Advocate (OCA) agreed to further process in this matter, including a delay in the implementation of Liberty's revised tariff beyond the period of suspension ordered by the Commission. *See* Notice of Adjudicative Proceeding at 5 (October 13, 2022) (suspending proposed revised tariff until December 1, 2022).

By agreement of the parties, by December 2, 2022, Liberty shall submit a second proposed revised revenue decoupling tariff for effect between January 1, 2023 and October 31, 2023. Furthermore, the DOE and the OCA shall have the opportunity to comment on that filing by December 9, 2022, before the Commission issues its order on or before December 16, 2022. The parties also agreed that the revenue decoupling adjustment shall be subject to audit by the DOE, and that the DOE shall file an audit report prior to September 1, 2023, which is Liberty's deadline for filing its revenue decoupling adjustment for the decoupling year ending June 30, 2023.

It has been determined that the deadlines established at the hearing are in public interest and are approved:

December 2, 2022 – Deadline for Liberty to file its second revised tariff pages.

December 9, 2022 – Deadline for the DOE and the OCA to file responses to Liberty's second revised tariff pages.

On or before December 16, 2022 – Order to be issued by the Commission.
