#### **Request for Approval of Allenstown Community Power Plan**

#### SUPPLEMENTAL ORDER OF NOTICE

The Town of Allenstown (Allenstown) filed its Community Power Electric Aggregation Plan (Community Power Plan) with the Commission on March 13, 2023 for the Commission's review and approval pursuant to RSA 53-E:7. On March 14, 2023, the Commission issued an order of notice stating that it would accept public comments for 21 days, pursuant to RSA 53-E:7, II, or until April 3, 2023.

On March 29, 2023, Allenstown filed a letter with the Commission stating that Allenstown did not send the statutorily required notice to Unitil Energy Systems, Inc. or the New Hampshire Electric Cooperative at the time Allenstown filed its Community Power Plan with the Commission. Allenstown represented that it sent notice of the Community Power Plan to both entities on March 20, 2023, but did not notify the Commission or the Office of the Consumer advocate until its March 29 filing. To rectify this omission, Allenstown requested that the Commission extend the public comment period in this docket, setting the deadline as twenty-one days from the date the Commission received its letter.

Consistent with that request, the Commission hereby provides notice that it will accept public comments on Allenstown's Community Power Plan within the first 21 days from the date the Commission received Allenstown's letter requesting an extension, or until **April 20, 2023.** Comments shall be addressed to the Chairman of the Commission, by mail at: 21 South Fruit Street, Suite 10, Concord, N.H. 03301-2429
