### 2023 Energy Service Solicitations

#### COMMENCEMENT OF ADJUDICATIVE PROCEEDING AND NOTICE OF HEARING

On April 5, 2023, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource or the Company) filed a letter notifying the Commission of its proposed 2023 default energy service solicitation scheduled for the Company's large and small customer groups. #### I. BACKGROUND AND PROCEDURAL HISTORY

The Commission approved the process used by Eversource to solicit default energy service supply for its large and small customer groups in Order No. 26,092 (December 29, 2017) issued in Docket No. DE 17-113. The large customer group consists of customers taking service under Primary General Service Rate GV, Large General Service Rate LG, Backup Service Rate B, and rates for any private outdoor area lighting associated with these accounts. *Id.* at 5. The small customer group consists of customers taking service under Residential Rates R and R-Time of Day, General Service Rates G and G-Time of Day, Outdoor Lighting Rate OL, and Energy Efficient Outdoor Lighting Rate EOL. *Id.* 

According to that process, Eversource procures the power supply for customers who do not take energy service from a competitive supplier by issuing separate

requests for proposals (RFPs) to the competitive energy market twice a year for its large and small customer groups. *See id.* at 13, 15-16. The RFPs solicit 100 percent of power supply requirements for each customer group for two 6-month periods, one beginning February 1 and the other beginning August 1. *See id.* at 10, 13, 15-16.

Eversource's April 5, 2023 filing indicated the dates for, among other things: (1) the issuance of its RFP; (2) the selection of the award group; (3) the filing of its petition and supporting documents with the Commission; and (4) the requested date of the Commission's decision, which is June 22, 2023. Eversource will solicit 100 percent of power supply requirements for the large customer group for the 6-month period beginning August 1, 2023. See id. at 6, 10-11. The rate for the large customer group will vary each month according to the monthly pricing of the winning bidder. See id. at 11. For the small customer group, Eversource will solicit power in approximately 100 megawatt tranches for 100 percent of the power supply for the 6-month period beginning August 1, 2023. See id. at 10-11. Once it selects a supplier or suppliers, Eversource will set a fixed monthly rate for the 6-month period beginning August 1, 2023. See id. at 10.

#### II. ISSUES PRESENTED

The filing presents, *inter alia*, the following issues: whether Eversource's power supply procurement is consistent with Order No. 26,092 (December 29, 2017) and RSA 374-F:3, V(c)-(e); and whether the resulting rates are just and reasonable as required by RSA 374:2, and RSA 378:5 and :7. Accordingly, an adjudicative proceeding will be convened to address these issues.

The Commission will be conducting any hearings scheduled in this matter in person. The Commission will consider requests to conduct hearings using a hybrid format to permit remote participation by a specific individual only if the Commission

has determined that a sufficient reason has been provided for why that individual would be unable to attend in person. Any party requesting that a specific individual be permitted to participate remotely should file a written request with the Commission's Clerk's Office no later than fifteen (15) days prior to the hearing date. If the Commission determines that one or more individuals will be permitted to appear remotely, then individuals in the Commission's hearing room, including the Commissioners, will be broadcast on a web-enabled platform.

### Based upon the foregoing, it is hereby

**ORDERED**, that an adjudicative proceeding be commenced for the purpose of reviewing and resolving the foregoing issues pursuant to RSA chapter 541-A, RSA 374-F:3, V(c)-(e), RSA 374:2, RSA 378:5 and :7, and the Commission's procedural rules; and it is

**FURTHER ORDERED**, that the Commission will hold a hearing in this matter at its offices located at 21 S. Fruit St., Suite 10, Concord, New Hampshire, on June 20, 2023, at 9:00 a.m. Three hours shall be allotted for this hearing; and it is

**FURTHER ORDERED**, that any entity or individual may petition to intervene and seek to be admitted as a party in this proceeding. Each party has the right to have an attorney represent the party at the party's own expense; and it is

**FURTHER ORDERED**, that, consistent with N.H. Admin. R., Puc 203.17 and Puc 203.02, any entity or individual seeking to intervene in the proceeding shall file with the Commission a petition to intervene with copies sent to Eversource and any other parties on the service list, on or before May 23, 2023. The petition shall state the facts demonstrating how the petitioner's rights, duties, privileges, immunities, or other substantial interests may be affected by the proceeding, consistent with N.H. Admin. R., Puc 203.17; and it is

**FURTHER ORDERED**, that any party objecting to a petition to intervene make said objection on or before June 2, 2023; and it is

**FURTHER ORDERED**, that parties shall file any proposed exhibits, written

testimony, motions, or other documents intended to become part of the record in this proceeding with the Commission. Pursuant to the secretarial letter issued on March 17, 2020, which is posted on the Commission's website at <a href="https://www.puc.nh.gov/Regulatory/Secretarial%20Letters/20200317-SecLtr-Temp-Changes-in-Filing-Requirements.pdf">https://www.puc.nh.gov/Regulatory/Secretarial%20Letters/20200317-SecLtr-Temp-Changes-in-Filing-Requirements.pdf</a>, all Commission rules requiring the filing of paper copies are suspended until further notice. Parties may elect to submit any filing in electronic form unless otherwise ordered by the Commission. Filings will be considered filed as of the time the electronic copy is received by the Commission; and it is

**FURTHER ORDERED**, that routine procedural inquiries may be made by contacting the Commission's Clerk's Office at (603) 271-2431 or <a href="ClerksOffice@puc.nh.gov">ClerksOffice@puc.nh.gov</a>. All requests to the Commission should be made in a written pleading filed with the Commission. Unless otherwise authorized by law, *ex parte* communications are prohibited; and it is

**FURTHER ORDERED**, that pursuant to N.H. Admin. R., Puc 203.12, Eversource shall notify all entities and individuals desiring to be heard at this hearing by publishing a copy of this order of notice on its website no later than two business days after the date of issue, such publication to be documented by affidavit filed with the Commission on or before April 28, 2023. In addition, the Clerk shall publish this order of notice on the Commission's website no later than two business days after the date of issue; and it is

**FURTHER ORDERED,** that any hearings in this matter shall be conducted in accordance with the attached hearing guidelines.
