Procedural Order Re: Scheduling Requests

On October 18, 2023, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) filed an assented-to statement clarifying the parties' positions on several scheduling issues in these dockets. Consistent with that joint statement, the Commission makes no changes to the schedule in Docket No. DG 22-045 and amends the schedule in Docket No. DE 23-044 as follows. First, the deadline for Liberty to submit its default service is December 7, 2023. Second, the hearing on default service will be on December 12, 2023 from 1:00 p.m to 4:00 p.m. Finally, the hearing on Class III RECs is rescheduled from December 19, 2023 to December 12, 2023 from 9:00 a.m. to 12:00 p.m.
