LIBERTY UTILITIES (ENERGYNORTH NATURAL GAS) CORP. d/b/a LIBERTY Request for Change in Distribution Rates

Prehearing Order

On September 21, 2023, the Commission held a prehearing conference in this matter pursuant to New Hampshire Code of Administrative Rules, Puc 203.15, and the Commission's Commencement of Adjudicative Proceeding Order No. 26,877 (August 25, 2023), which was attended by representatives of: Liberty Utilities (EnergyNorth Natural Gas) Corp d/b/a Liberty (Liberty); the New Hampshire Department of Energy (DOE); and the Office of the Consumer Advocate (OCA). During the prehearing conference, the Commission addressed matters that included the following:

1. <u>Sufficiency of Notice</u>

Liberty, as ordered by the Commission in Order No. 26,877, filed a timely affidavit of publication with the Commission on August 31, 2023, attesting to the fact that Liberty published Order No. 26,877 on its website on August 28, 2023, and in the <u>Manchester Union Leader</u> on August 30, 2023.

2. <u>Requests to Intervene</u>

No request to intervene was filed with the Commission as of the date of the prehearing conference (September 21), nor has a late-filed request to intervene been filed as of the date of this Prehearing Order (October 19).

3. <u>Clarification of Issues Presented</u>

Liberty provided an executive summary presentation of its rate case proposals

at the prehearing conference and responded to Commission inquiries regarding the presentation. *See* Transcript of September 21, 2023 Prehearing Conference (Tr.) at 26-46. The Commission made inquiries and indicated areas of interest presented by this proceeding in Order No. 26,877. The OCA and the DOE provided their own elaborations of their initial positions, which are summarized below.

The DOE indicated that it was concerned by the scale of Liberty's proposed rate increase, insofar as it would be more than double the size of the last two Liberty rate increase requests combined. Tr. at 7-8. To assess the reasons for this increase, the DOE stated that it would review Liberty's investments in utility plant. Tr. at 8. The DOE also flagged issues relating to the timing of Liberty's investments in its computer systems; the treatment of \$8.5 million in decoupling revenue during the test year; treatment of revenues that are received through the LDAC, but relate to the Gas Assistance Program Customers; and the appropriateness of Liberty's proposed return on equity, with the DOE's initial position being that it is "too high." Tr. at 8-12. Furthermore, the DOE raised issues of concern regarding specific rate treatments for Liberty's "iNATGAS" customer; the Liberty proposal for three, instead of the usual two, step adjustments; issues with the proposed \$24 million conversion of the Keene Division system from propane-air to natural gas; and the \$10 million Liberty proposal for cybersecurity investments. Tr. at 12-14.

The OCA stated at the prehearing conference that it shared the DOE's concern regarding the size of the proposed rate increase, and that the OCA would explore the potential for an alternative rate design approach for Liberty, based on input generated by OCA's consultant. Tr. at 15.

On further reflection, and with the input of the DOE and OCA before us, the Commission hereby rules that it will take special attention to the various matters of concern presented by the DOE and the OCA in this proceeding, with ratemaking treatment of decoupling revenues, application of the RLIAP provisions of the Liberty tariff, and related matters to be explored comprehensively. This is an elaboration of the comprehensive list of issues presented in Order No. 26,877.

4. Discovery

The DOE indicated to the Commission at the prehearing conference that it had propounded two sets of data requests on Liberty, with the assistance of its technical consultant, Blue Ridge Consulting. Tr. at 14. The OCA stated that it had retained Larkin & Associates as its technical consultant to assist with discovery work. Tr. at 15. More rounds of discovery were planned as part of the jointly-proposed procedural schedule filed with the Commission on September 28, 2023 (discussed in Part 6 below).

As part of this Prehearing Order, the Commission hereby requests that the DOE file copies of its outbound discovery propounded on Liberty and other parties with the Commission to facilitate the Commission's monitoring of this proceeding and to avoid redundancy in the Commission's issuance of record requests.

5. <u>Pending Motions</u>

The DOE and OCA indicated at the prehearing conference that they had no objections to Liberty's two motions for protective treatment filed for material submitted in connection with this proceeding, that relating to compensation information for Liberty's directors and officers, and technical spreadsheet information filed by Liberty pursuant to Order No. 26,877. The Commission will issue an Order dispositioning these Liberty motions in the near future.

6. <u>Procedural Schedule, Including Final Hearing Date(s) and Amount of Time</u> <u>Required</u>

At the prehearing conference, Chairman Goldner noted that the one-year

deadline for resolution of Liberty's rate case proposal in this proceeding would be July 26, 2024, and that the Commission would request a procedural schedule proposal from Liberty, the DOE, and OCA by October 16, 2023. Tr. 19.

On September 28, 2023, the parties (Liberty, DOE, and OCA) filed a joint procedural schedule proposal with the Commission. For simplicity and brevity, the Commission hereby APPROVES the proposed schedule, with slight modifications presented in RED, with follow-up explanation below, as just, reasonable, and in the public interest. We also approve the parties' proviso that all data request responses will be due 10 business days from the issuance of the data requests, unless otherwise specified.
