Procedural Order Re: Request to Reschedule February 14, 2024 Hearing


The Commission issued a procedural order on February 12, 2024 scheduling a hearing on February 14, 2024 regarding the implications of Burgess Biopower, LLC's and Berlin Station, LLC's Chapter 11 bankruptcy filings. On February 13, 2024, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a request to reschedule this hearing to February 21, 2024, at 9:00 a.m., when the continuation of the January 19, 2024 hearing has been scheduled, due to the limited availability of certain personnel on short notice. Eversource did not state in its request whether it had contacted either the New Hampshire Department of Energy or the Office of Consumer Advocate to obtain their positions on its request. *See* N.H. Admin. R., Puc 203.13(b).

Given the short amount of time remaining before February 14 hearing, the Commission waives New Hampshire Code of Administrative Rules, Puc 203.07(e). Eversource's request to reschedule the February 14 hearing is DENIED. The Commission has determined that it is necessary to obtain additional information about the implications of Burgess Biopower, LLC's and Berlin Station, LLC's bankruptcy filings prior to the February 21 hearing. Eversource is requested to file the exhibits referred to in Footnote 1 of its February 13, 2023 letter.


