Procedural Order Re: Proposed Procedural Schedule

The Commission approves the proposed assented-to procedural schedule filed by Pennichuck East Utility, Inc., Pittsfield Aqueduct Company, and Pennichuck Water Works, Inc. (collectively, the Joint Petitioners) on February 28, 2024, with the exception of the parties' proposed hearing dates. The Joint Petitioners shall notify the Commission by September 30, 2024 of three dates (on Tuesdays, Wednesdays, or Thursdays) when all parties will be available for a hearing, how much time will be required, and whether a settlement or litigation track has been chosen. If a litigation track is chosen, then the hearing dates shall be at least three weeks after the parties' last filing.

A status conference is scheduled on October 16, 2024, at 9:00 a.m. During the status conference, the evidence to be produced at hearing, the order of witnesses, and other prehearing matters will be discussed.
