Energy stated that the amended procedural schedule would optimize the parties' resources and would not unduly delay this proceeding. The Commission is not available for hearings on the proposed dates of November 1 and 5, 2021, at 10:00 a.m. Accordingly, the hearing is scheduled on Wednesday, November 3, and Thursday, November 4, 2021, starting at 9:00 a.m.
