## **ORDER OF NOTICE**

Northern Utilities, Inc. d/b/a Unitil (Northern) is a public utility pursuant to RSA 362:2 that provides natural gas service to customers in Maine and in the seacoast region of New Hampshire. On July 22, 2019, Northern filed a petition for approval of its 2019-2024 Least Cost Integrated Resource Plan (LCIRP) pursuant to RSA 378:38 and Order No. 26,027 (June 19, 2017). Northern also filed a motion for protective order and confidential treatment regarding the LCIRP filing.

The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at <a href="http://puc.nh.gov/Regulatory/Docketbk/2019/19-126.html">http://puc.nh.gov/Regulatory/Docketbk/2019/19-126.html</a>.

The LCIRP filing raises, <u>inter alia</u>, issues related to whether Northern's LCIRP is adequate under the requirements set forth in RSA 378:38 and RSA 378:39, as amended by the Legislature; and whether Northern's filing adequately addresses the Commission's requirements set forth in Order No. 26,027.

Each party to this proceeding has the right to have an attorney represent the party at the party's own expense.

## Based upon the foregoing, it is hereby

ORDERED, that a Prehearing Conference, pursuant to N.H. Code Admin. Rules Puc 203.15, be held before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on September 4, 2019 at 10:00 a.m., at which each party will provide a preliminary statement of its position with regard to the petition and any of the issues set forth in N.H. Code Admin. Rules Puc 203.15; and it is

**FURTHER ORDERED**, that, immediately following the Prehearing Conference, Northern, the Staff of the Commission, and any Intervenors hold a Technical Session to review the petition; and it is

**FURTHER ORDERED**, that pursuant to N.H. Code Admin. Rules Puc 203.12, Northern shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than August 12, 2019, in a newspaper with general circulation in those portions of the state in which operations are conducted, publication to be documented by affidavit filed with the Commission on or before August 30, 2019; and it is

FURTHER ORDERED, that consistent with N.H. Code Admin. Rules Puc 203.17 and Puc 203.02, any party seeking to intervene in the proceeding shall submit to the Commission seven copies of a Petition to Intervene with copies sent to Northern and the Office of the Consumer Advocate on or before August 30, 2019, such Petition stating the facts demonstrating how its rights, duties, privileges, immunities, or other substantial interests may be affected by the proceeding, consistent with N.H. Code Admin. Rules Puc 203.17; and it is

**FURTHER ORDERED**, that any party objecting to a Petition to Intervene make said Objection on or before September 4, 2019.
