Dear Ms. Gold:

On December 18, 2020, Shell Energy North America (US), L.P. (Shell), a registered competitive natural gas supplier (CNGS), submitted an application to renew its CNGS registration. Shell was granted a waiver of N.H. Admin. R., Puc 3003.02 to file its registration renewal application by December 21, 2020 and to extend its current registration so it could continue to provide competitive natural gas service to its commercial customers. *See* Secretarial Letter dated December 18, 2020 issued in Docket No. DM 15-421.

On January 20, 2021, Commission Staff (Staff) filed a memorandum, in which it confirmed its review of Shell's renewal application and its conclusion that the application meets the requirements for registration under Puc 3000. Staff recommended that Shell's registration renewal application be approved for a five-year term, beginning on November 30, 2020.

The Commission has reviewed and approved Staff's recommendation. Accordingly, Shell's application for renewal of its CNGS registration is approved, effective as of November 30, 2020. The renewed registration is for a term of five years and expires at the close of business on November 30, 2025. Pursuant to Puc 3003.02(b), Shell must submit its next renewal application at least 60 days prior to the expiration of the approved registration term, on or before October 1, 2025.

Please be aware that each registered CNGS is subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf.
