Re: DM 21-010, Titan Energy New England Application to Renew Registration as Provider of Natural Gas Aggregation Services

Dear Mr. Hawkins:

On January 22, 2021, Titan Energy New England (Titan) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on January 27, 2021, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Titan's registration renewal application be approved for a two-year term, beginning on January 11, 2021. Staff filed a supplemental memorandum on January 28, 2021, in which it noted that, pursuant to Puc 3003.06(a), Titan's renewal application should have been filed at least 60 days prior to the expiration of its currently-effective registration, on or before November 12, 2020, and recommended that a waiver of Puc 3003.06(a) be granted and that Puc 3003.06(h) also be waived to permit Titan's renewed registration to be effective as of January 11, 2021.

The Commission has approved Staff's recommendations and granted the proposed rule waivers. Accordingly, Titan's application for registration renewal is approved, effective as of January 11, 2021. The renewed registration is for a term of two years and expires at the close of business on January 11, 2023. Pursuant to Puc 3003.06(a), Titan must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before November 12, 2022.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: <u>http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf</u>.
