On February 10, 2021, Service King International Brokers, LLC (Service King) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services. On March 4, 2021, Service King filed additional information completing the renewal application.

Commission Staff (Staff) filed a memorandum on March 16, 2021, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that Service King's registration renewal application be approved for a two-year term, beginning on March 7, 2021.

The Commission has approved Staff's recommendation. Accordingly, Service King's application for registration renewal is approved, effective as of March 7, 2021. The renewed registration is for a term of two years and expires at the close of business on March 7, 2023. Pursuant to Puc 3003.06(a), Service King must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before January 6, 2023.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules.
