## Re: DM 21-031, Crimson Power Solutions, LLC Application to Renew Registration as Provider of Natural Gas Aggregation Services

Dear Mr. Schmitt:

On March 1, 2021, Crimson Power Solutions, LLC (Crimson) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on March 8, 2021, summarizing its review of the application and recommending that a waiver be granted of the renewal application filing deadline under N.H. Admin. R., Puc 3003.06(a) and that Crimson's registration renewal be approved for a two-year term, beginning on February 26, 2021.

The Commission has granted the recommended rule waiver, having found that it would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, under Puc 201.05. Accordingly, Crimson's application for registration renewal is approved, effective as of February 26, 2021. The renewed registration is for a term of two years and expires at the close of business on February 26, 2023. Pursuant to Puc 3003.06(a), Crimson must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before December 28, 2022.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf.
