Procedural Order Re: Rate Case Expenses and Reconciliation Review

In Order No. 26,635 (June 2, 2022), which was subsequently revised, the Commission approved the parties' settlement agreement, including those provisions requiring the New Hampshire Department of Energy (DOE) to review, and submit a report to the Commission regarding, Hampstead Area Water Company, Inc.'s (HAWC) rate case expenses and temporary to permanent rate reconciliation filing. *Id.* at 20-21; Settlement Agreement filed on May 9, 2022, Subsections II(A)(ii)(4) and (6). HAWC submitted this filing on June 30, 2022, but the DOE has not yet filed the results of its review.

The DOE is requested to file the results of its review of HAWC's rate case expenses and reconciliation filing <u>on or before September 30, 2022.</u>
